

has declared Prince Ernest Augustus, the Elektor of Hannover's youngest Brother, Major-General of the Army; and Colonel Withers, Colonel Stanley, and Colonel Frederick Hamilton, are appointed Brigadiers of the three English Brigades. Many Deserters are lately come over to us from the Enemy; and we have an Account, that a Captain, with several other Officers, and 60 Troopers, all mounted, belonging to the Garrison of Bonn, being upon an Out-Guard, deserted together, and came to the Camp of the Allies at Malheim.

Paris, July 17. The Count de Tolouse, Great Admiral of France, sailed from Toulon the 6th Instant with 15 Men of War, as is said towards Naples. It is said, the Duke of Burgundy has sent a Detachment of his Army under the Command of Monsieur Chamaraute to reinforce Marshal Camille's Army.

Hague, July 25. M. S. Many Conferences have been held here between the Ministers of the King of Prussia and the other Parties concerned for Settling the Succession of the late King, and it is said, a Project of a Provisional Treaty is offered, whereby the King of Prussia would have the Countries of Leiningen and Meurs, and all the other Territories and Estates that were enjoyed by Prince Frederick Henry, and the young Prince of East-Frisland the Countries of Buren, Lichtenstein, and other Lands and Estates which fell to the Share of Prince Maurice. The King of Prussia went the 21st to Hainster-lyke, to take Possession of that House, which, according to the Proposal above-mentioned that is accepted by his Majesty, would fall to his Share, together with the House in this Town called the Old Court, and that of Ryswick; The Houses of Los, Dieren, Sesslyke, and the House in the Wood near this Place, being to fall to the young Prince of Frisland; and his Majesty returned thither the 23d, and it is said, he intends to leave this Place in a day or two, in order to return home. The Prince of Nassau Saarbruck is gone to Swabach, near Wisbaden, in the County of Nassau, to use the Waters of that Place. We have an Account, that the Dutch home-ward-bound East-India Fleet, consisting of 19 Sail of Merchant Ships richly laden, is lately arrived in the Texel. The Steur Punt lies in the Port of Dunkirk with a Squadron of French Frigats, but darts not stir out, a Squadron of English and Dutch Men of War lying before that Place to observe him.

Come, July 15. Yesterday morning the Wind coming to the North East the Mary and Sarah of London, bound to Nevis, and 3 other Merchant Ships bound for Ireland, which were at Spithead, took that Opportunity to Sail, under Convey of Her Majesty's Ship the Skornia; Soon after Noon the Wind came about again to the South-west.

St. James's, July 17. Her Majesty has been pleased by Letters Patents dated at Westminster the 11th of July, in the 11th year of Her Majesty's Reign, to Revoke and Determine certain Letters Patents, bearing date at Westminster the 15th day of May, in the 9th year of His late Majesty's Reign, whereby the Rt. Honourable Thomas Lord Wharton was constituted Warden and Chief Justice and Justice in Eyre of all His Majesty's Forests, Chaces, Parks and Warrens on this side Trent.

Whitehall, July 29. Her Majesty has been pleased to constitute his Grace the Duke of Newcastle Warden of the Forrest of Sherwood, in the County of Nottingham.
