

self and that Duke, concerning the Nomination to such Benefices as become vacant in his Territories. The Number of those who are Favourers of the Emperor's Interest is considerably increased in the Kingdom of Naples, and they all take Refuge in the Province of *Abruzzo*, bordering on the Ecclesiastical Territories, where great Bodies of them are got together, who destroy the Estates of those *Neapolitans* that are in the *French* Faction, and raise Contributions upon the *French* Subjects, accusing him of Partiality to the *French*, so that the Pope has been obliged to send more Forces that way to guard his Frontier, and he has appointed a Congregation of Cardinals to consider what is further to be done for their Security. They write from *Naples*, that the Magistrates of that City having resolved to make a Free Gift of 400000 Ducats to the King of *Spain*, they laid a Tax upon Windows, but that has produced no more than 70000 Ducats, and Trading there is so dead, and the People to generally poor, that they are at a loss what other Method to take for the making up of this Sum, which is expected from them.

Venice, July 28. The *French* Frigats commanded by the *Chevalier de Tourbin* continue to cruize in our Gulph, to the great Interruption of our Trade; for under Pretence of hindering the Transportation of Corn and other Provisions from *Fiume* to *Mezzola*, where there is a great Magazine for the use of the Imperial Army, they stop every Ship that passes, and commit great Disorders, particularly the last week they seized one of our Merchant Ships which was going to *Ragusa*, on board which was a Merchant of that Country, from whom they took to the value of 1000 Ducats in Money, and having plundered the Vessel, set the Men ashore and burnt her.

Bristol, August 3. Last night came in here Her Majesty's Ships the *Scarabon* and the *Arundel* from *Plymouth*, with the *Diligence*, the *Plain Dealing*, and the *Paulip* and *John*, which came under their Convoy from *Rotterdam*. The *Scarabon* took an *English* Vessel that came from *Leghorn*, laden with Oil and Wine, bound for *Lisbon*, which two small Privateers had taken some days before end of the Lands-end.

Deal, August 7. Her Majesty's Ships the *Deale-Castle*, *Betty*, and *Margate*, came this day into the *Downs*, with the *Byn* from *Guinea*, the *Glover* Galley from *Leghorn*, the *Mary* from *Antigua*, and divers other homeward-bound Merchant Ships under their Convoy.

Windsor, August 5. Monsieur de *Stoeken*, Envoy Extraordinary from the King of *Denmark*, had this day a Private Audience of Leave of Her Majesty, after which he had Audience of Leave in like manner of His Royal Highness Prince *George* of *Denmark*.

The Count de *Platten*, Envoy Extraordinary from the Elector of *Hanover* and the Duke of *Ceb*, had likewise this day Private Audiences of Leave of Her Majesty, and of His Royal Highness Prince *George* of *Denmark*; to which Audiences they were both Introduced by Sir *Charles Costrell* Master of the Ceremonies.

The *Swedish* Resident's Audience, mentioned in the last Gazette, was a Private Audience.
