And whereas in the year One thousand nine hundred and twenty-one the Governing Body acquired by purchase the freehold messuages land and hereditaments delineated and coloured mauve on the said plan for the purposes of the School in consideration of an annual rentcharge of Three hundred pounds for twenty years, and at or about the same time the Governing Body acquired the lease-hold hereditaments delineated on the said plan and the same time the Governing Body acquired the lease-hold hereditaments delineated on the said plan and therein coloured magenta for the purposes of the School, And the said purchases were sanctioned by a further Amending Scheme proposed by the Govern-ing Body on the eighth day of August One thousand nine hundred and twenty-one, which Amending Scheme was duly approved and sanctioned by an Order of His late Majesty King George V in Council dated the thirty-first day of October One thousand nine hundred and twenty-one nine hundred and twenty-one

And whereas in the year One thousand nine hundred and twenty-four the Governing Body acquired by purchase the freehold messuages lands One thousand nine and hereditaments delineated on the said plan and therein coloured dark green for the purposes of the School and the said purchase was sanctioned by a School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the eleventh day of April One thousand nine hundred and twenty-four, which Scheme was duly approved and sanctioned by an Order of His late Majesty King George V in Council dated the twenty-fifth day of June One thousand nine hundred and twenty-four

And whereas in the year One thousand nine hundred and thirty the Governing Body acquired by purchase the freehold messuages lands and hereditaments delineated on the said plan and therein coloured burnt sienna for the purpose of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the twenty-first day of December One thousand nine hundred and twenty-nine, which Scheme was duly approved and sanctioned by an Order of His late Majesty King George V in Council dated the ftwenty-eighth day of March One thousand nine hundred and thirty

And whereas in the year One thousand nine hundred and thirty-seven the Governing D acquired by purchase the freehold messuage premises delineated on the said plan and th Body and therein premises delineated on the said plan and therein coloured yellow hatched green for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Govern-ing Body on the first day of May One thousand nine hundred and thirty-seven, which Scheme was duly approved and sanctioned by an Order of H s late Majesty King George V in Council dated the twenty-ninth day of July One thousand nine hundred and thirty-seven and thirty-seven

And whereas in the year One thousand nine hundred and forty-five the Governing Body acquired by purchase the freehold piece or parcel of land delineated on the said plan and therein coloured red hatched red for the purposes of the School and the said purchase was sanctioned by a further Amending Scheme proposed by the Governing Body on the third day of April One thousand nine hundred and forty-five, which Scheme was duly approved and -sanctioned by an Order of His Majesty King George VI in Council dated the third day of August One thousand nune hundred and forty-five One thousand nine hundred and forty-five.

And whereas all the said purchases were greatly to the benefit of the School and were rendered necessary chiefly by the increase in the number of the boys attending the School.

And whereas grievous difficulties having arisen touching the provision of lodging for the assistant masters of the School the Governing Body have for some time past sought to acquire a messuage in the purlieus of the School which by reason of its design could without undue expense be converted into sepa-rate dwellings for the use of assistant masters as aforesaid aforesaid

And whereas the Governing Body in furtherance of such intent did on the third day of August One thousand nine hundred and forty-six enter into an agreement with one Gerald Louis Johnson Tuck C M G. D S O. (conditionally on the sanction of His Majesty in Council being first had and obtained) to purchase for the sum of £6300 a freehold messuage to purchase for the sum of £0300 a freehold messuage or dwellinghouse and cottage and land known as i'Woodfield'' (being the land and hereditaments more particularly described in the Schedule to these Presents) which said land and hereditaments are coloured brown hatched brown on the plan hereto annexed annexed.

And whereas the purchase of the said messuages and premises is very desirable in the interests of the School for the reasons hereinbefore appearing

And whereas it is apprehended that the Governing Body have not power under the Original Scheme or

the said Amending Schemes to acquire the land and hereditaments described in the Schedule hereto The Governing Body of Shrewsbury School do hereby propose by virtue of and in pursuance of the *p*owers hereinbefore mentioned to alter the Original Scheme as follows (that is to say)

That the Original Scheme shall throughout be read and construed as though the land and hereditaments described in the said Schedule hereto and delineated on the plan hereto annexed and thereon coloured brown hatched brown had been described in the Schedule to the Original Scheme and delineated on the plan thereto annexed and thereon coloured as last aforesaid And that the said Agreement of the third day of August One thousand nine hundred and forty-six and the carrying into effect thereof may be deemed to have been authorized by the Original Scheme
