The KING has been graciously pleased to ordain and declare that Deborah Mary, Wife of Anthony Vyvyan Thomas, Esquire, Commander in the Royal Navy (retired), Shirley Joan, Wife of George Drayson, Gentleman, Rachel Kathleen Wife of Dimitri Zvegintzov, Esquire, Colonel the Border, Regiment and Elspeth Lorraine, Wife of Geoffrey Randolph Dixon Musson, Esquire, Commander of the Most Excellent Order of the British Empire, Companion of the Distinguished Service Order, Colonel the King's Shropshire Light Infantry, shall henceforth have, hold and enjoy the same title, rank, place, pre-eminence and precedence as the daughters place, pre-eminence and precedence as the daughters of a Baron, which would have been due to them had their father, Herbert Crawshay Bailey, Esquire (commonly called the Honourable Herbert Crawshay Bailey) survived his nephew Wilfred Russell, Baron Glanusk and succeeded to the title and dignity of Baron Glanusk. TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 29th October, 1948, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £170,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 1st November, 1948, to Saturday, the 6th November, 1948, inclusive, and will be pay-able at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates different dates.

different dates. 5. Tenders must be made through a London Banker, Discount House or Broker. 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated. 7. Members of the House of Commons are not precluded from tendering for these Bills.

LONDON HACKNEY CARRIAGES ACT, 1850. CAB STANDINGS.
