RECRUITMENT UNDER NORMAL REGULATIONS TO THE CLERICAL CLASSES (GENERAL AND DEPARTMENTAL) OF THE HOME CIVIL SERVICE AND TO CLERICAL POSTS IN BRANCH B OF THE FOREIGN SERVICE.

1. Age.

Candidates must be at least 16 and under 18 years of age on 1st March, 1949.

But-

But— (i) Candidates who have served in any estab-lished post to which they were admitted with the certificate of the Civil Service Commissioners may deduct from their actual age any time not ex-ceeding two years which they may have spent in such service before 1st March, 1949. (ii) Candidates employed on the first day of the examination as Established Clerical Assistants in the Civil Service may be admitted to the examina-tion if under the age of 20 on 1st March, 1949. (iii) Candidates appointed as Established Typists in the Civil Service from an Open Competition who were under 17 years of age on the governing date for age for that Competition, may be admitted to the examination, provided that they have con-

to the examination, provided that they have continued to be employed in the Established Typing Grades of the Civil Service up to the first day of the examination, and that they are under the age of 20 on the 1st March, 1949.

2. Sex.

Both boys and girls are eligible.
