If an objection is submitted within the prescribed time, however, the Committee will be prepared, if they are satisfied that sufficient grounds exist, to allow the later submission of evidence or explanation in support of the objection. EXPLANATORY NOTE.

These Regulations amend the National Insurance (Classification) Regulations, 1948, by enlarging the existing provision whereby persons acting as occasional helpers to, or substitutes for, weavers of certain classes for not more than one day on each occasion are treated as non-employed persons under the National Insurance Act, 1946. The amendment allows persons to act, whether occasional or otherwise, as helpers or substitutes on two days in a wise, as helpers or substitutes on two days in a contribution week in any one mill without thereby becoming employed persons.
