#### MINISTRY OF TRANSPORT.

##### TRUNK ROADS ACT, 1946.

The Minister of Transport hereby gives notice that he proposes to make an Order under section 1 of the Trunk Roads Act, 1946, the effect of which will be that a new road which he proposes to construct from a point north-west of Hatch End in the county of Middlesex to Cassio Bridge in the County of Hertford will become a trunk road on the date when the Order comes into operation.

Copies of the draft Order and the plan showing the line of the new road may be inspected by any person free of charge at all reasonable hours during a period of three months from 26th November, 1948, at the offices of the Ministry of Transport, Berkeley Square House, London, W.1, or at the offices of the Hertfordshire County Council, County Hall, Hertford, or at the offices of the Middlesex County Council, Guildhall, Westminster, S.W.1, or at the offices of the District Surveyor, 4, The Avenue, Watford, Herts.
