Route No. 2 (4 furlongs 5 chains or thereabouts Route No. 2 (4 furlongs 5 chains or thereabouts in length) commencing at the termination of Route No. 1 hereinbefore described proceeding along Birchington Avenue to its junction with Broadway (forming part of Road A.1085) crossing Broadway and thence continuing along Birching-ton Avenue to and terminating at a point therein 4 chains or thereabouts north-west of the junction of Birchington Avenue with Kingsley Road.

2. To extend and apply with or without modifica-tion to the trolley vehicles to be used by the Board under the powers of the intended Order and to the said routes the provisions of the existing Acts re-lating to the Board and of the enactments incor-porated therewith in so far as those provisions relate to the use which are the same provisions relate

to trolley vehicles. 3. To empower the constituent authorities of the Board to borrow moneys for the purposes of the in-tended Order; and to confer on the Board and the authorities all other said constituent necessary financial powers.

4. To vary or extinguish all rights powers and privileges inconsistent with or which would or might in any way interfere with any of the objects of the intended Order and to confer other rights and privileges.
