FACTORIES ACTS, 1937 AND 1948.

In pursuance of Section 129 of the Factories Act, 1937, and the second Schedule to that Act, the Minister of Labour and National Service hereby gives notice that he proposes to make Special Regulations under Sections 46 and 60 of the Act applying (subject to certain exceptions) to factories in which the manufacture or decoration of pottery is carried on or in which, for use in the manufacture or decoration of pottery, lithographic transfers, frits or glazes are made, or flint or quartz is ground or powdered, or ground or powdered flint or quartz is mixed with clay or other material to form the body of the ware. The proposed Special Regulations, which are entitled the Pottery (Health and Welfare) Special Regulations, 1949, are intended to supersede the Regulations of 1913 for the Manufacture and Decoration of Pottery, and the Pottery (Silicosis) Regulations, 1932, but not the Pottery (Health) Special Regulations, 1947.
