##### RETAIL BESPOKE TAILORING WAGES COUNCIL (ENGLAND AND WALES).

The Retail Bespoke Tailoring Wages Council (England and Wales) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals (1) for the revocation of the Retail Bespoke Tailoring Wages Council (England and Wales) Wages Regulation (Holidays) Order, 1947 (Order R.B.
