At the Court at *Sandringham*, the 28th day of *January*, 1949.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of *January*, 1949 (N. 11985/48), in the words following, viz. :—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by an Order in Council dated the 19th day of *August*, 1871, sanction was given to the introduction of the rating of Band Boy in the Royal Navy:

"And whereas by an Order in Council dated the 20th day of *May*, 1903, provision was made for the entry of Band ratings, including Band Boys, into the Royal Marines:

"And whereas we are of opinion that the title 'Band Boy' does not now reflect the standard of musical training which the rating receives:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the alteration of the title from 'Band Boy' to 'Boy Musician':

"The Lords Commissioners of Your Majesty's Treasury have been informed of this alteration."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 21st day of *December*, 1948, in the words and figures following, that is to say:—

"We, the Church Commissioners, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st

and 32nd years of Her said late Majesty, Chapter 114, have prepared the following Scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of *Ebchester* in the diocese of *Durham*:

"Whereas we are satisfied that *Thomas William Christopher Smith*, of 51, *The Drive*, *Benton*, in the *City and County of Newcastle on Tyne*, Esquire, is the patron or person entitled to present or nominate to the said benefice:

"And whereas the said *Thomas William Christopher Smith* desires to transfer the advowson of the said benefice to the *Bishop of Durham* for the time being and is consenting to this Scheme (in testimony whereof he has executed the same):

"And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

"Now, therefore, with the consent of the Right Reverend *Alwyn*, *Bishop of Durham* (in testimony whereof he has executed this Scheme), we, the said Church Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the *London Gazette* of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said *Alwyn*, *Bishop of Durham*, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the *Bishop of Durham* for the time being."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the *London Gazette* pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of *Durham*.
