DISEASES OF ANIMALS ACTS, 1894 to 1937.

Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

Statutory Instruments, 1949 No. 241. he Foot-and-Mouth Disease (Infected Areas) Special Order No. 2, 1949. (Made 16th February, 1949.)

Declares an area comprising the districts situate within approximately 15 miles of Diss, Norfolk, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Norfolk, East Suffolk and West Suffolk.

The Live Poultry (Regulation of Sales, Exhibitions and Movements) (Amendment) (No. 2) Order, 1949, Made 17th February, 1949.

This Order permits, as from 1st March, 1949, the carriage of poultry by rail, or partly by rail and partly by road, through the areas described in the Schedule to the Live Poultry (Regulation of Sales, Exhibitions and Movements) (Amendment) Order, 1949, provided they are consigned on a through booking from a railway station outside such areas.

It prohibits the consignment of poultry from stations within the areas already mentioned, unless the movement of the poultry has been licensed by

give notice of a proposal by them to carry out the undermentioned Work or Works under their powers contained in the Mersey Docks and Harbour Board Act, 1945, with the consent of the Lords of the Admiralty as provided for in Section 357 of the Mersey Dock Acts Consolidation Act, 1858:—

Construct in the County Palatine of Lancaster, partly in the city of Liverpool and partly in the county borough of Bootle, an entrance lock from the River Mersey to the Langton Dock, partly inside the present River Wall, partly in Canada Basin and partly outside the present River Wall on the bed above or foreshore of the River and in the lines or situations and according to the levels the lines or situations and according to the levels shown upon the plan and sections.

The permanent works to be constructed on the bed shore or foreshore and in the tidal waters of the River are as follows:

A river wall abreast of Canada Dock, A pierhead abreast of Canada Basin, and Part of the sides and floor of the lock.

The total length of the permanent works, measured in a straight line in a Northwardly direction from a point abreast the Southern end of Canada Dock, is approximately two thousand five hundred linear feet, and the maximum projection into the River, measured at right angles to the present River Wall, is approximately one hundred and twenty linear feet.

The whole of the permanent work is to be of solid construction in concrete or masonry and is to include lock-caissons and machinery, culverts.

The temporary works to be constructed on the bed shore or foreshore include an embankment abreast of Canada Basin.

The total length of this work, measured in a straight line in a Northwardly direction, is approximately one thousand linear feet and the maximum projection into the River, measured at right angles to the present River Wall, is approximately four hundred and fifty linear feet.
