"The whole of the endowments set forth in the Schedule being subject to a duly authorised Mortgage of the same to us dated the Third day of July, One thousand nine hundred and thirty three, securing an advance to the then Bishop of Blackburn of the sum of £1,000 for improvements to the said Episcopal Residence of which sum the amount of £65 10s. 4d. still remained outstanding on the Third day of July, One thousand nine hundred and forty eight."

"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, and with the consent of the Right Reverend William, Bishop of Manchester (in witness whereof he has signed this Scheme), have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the union of the benefice of Weaste, Saint Luke, and the benefice of Weaste, All Saints, both situate in the diocese of Manchester. "1. Union of Benefices and Parishes. The said benefice of Weaste, Saint Luke, and the said benefice of Weaste, All Saints, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Weaste Saint Luke with All Saints' and the parishes of the said benefices shall also be united into one parish for exclesiastical nurposes.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect.

"3. Parish Church. The parish church of the parish of Saint Luke, Weaste, shall be the parish church of the united parish.

"4. Registers. The marriage registers in duplicate current at the Church of All Saints, Weaste, shall be sent by the incumbent of the united benefice to the Registrar General to be closed officially.

"5. Patronage. With the consent (testified as aforesaid) of the said Bishop of Manchester, being the patron of the said benefice of Weaste, All Saints, the patronage of the said benefice of Weaste, All Saints, shall be surrendered to the patrons of the said benefice of Weaste, Saint Luke, to the intent that the patronage of the said united benefice shall belong wholly to the patrons of the said benefice of Weaste, Saint Luke.

(i) the incumbent of the united benefice shall employ a second curate to assist principally (but not to the exclusion of general duties in the united parish) in the ministrations of All Saints Church; Provided that in the event of the services of a whole-time second curate not being available the said incumbent shall employ such other clerical or lay assistance as the Bishop shall from time to time direct: direct ;

(ii) a portion of the endowments of the united benefice, namely an annual sum of £282 (being part of a larger annual payment at present made by us, the said Church Commissioners, to the incumbent for the time being of the said benefice of Weaste, All Saints) shall be appropriated by us as a fund towards the cost of such assistance as aforesaid and such fund shall be paid by us, the said Church Commissioners, to the Diocesan Board of Finance of the diocese as trustees to apply it accordingly.
