The KING's Most Excellent Majesty in Council. WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the Tweffth day of July, 1945, in the words and figures following, that is to say:— "We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures. 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which with the consents of the Right Reverend Richard, Bishop of Saint Edmundsbury and Ipswich, and of the Right Reverend Edward, Bishop of Ely (in witness whereof they have signed this Scheme) we have prepared for effecting the union of the benefice of Newmarket, All Saints, in the diocese of Saint Edmundsbury and Ipswich and a part of the benefice of Cheveley in the diocese of Ely: Ely:

#### " SCHEME.

"SCHEME. "1. Boundaries: With the consents (testified by their signing this Scheme) of the Reverend Canon Thomas Robert Browne and of the Reverend Leonard Byam Sewood Abbott as the incumbents respectively of the said benefices of Newmarket, All Saints, and Cheveley, upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette a part of the benefice and parish of Cheveley (the boundaries of which part are described in the schedule hereto and are shown upon the map annexed to this Scheme) shall be severed from the remaining part of that benefice and parish and united to the benefice and parish of Newmarket, All Saints. "2. Endowments: Upon the union taking effect or upon the vacation of the benefice of Cheveley by the Reverend Leonard Byam Sewood Abbott (which-ever be the later) a capital sum of £1,600 being part of a sum of money appropriated or to be appro-

ever be the later) a capital sum of £1,600 being part of a sum of money appropriated or to be appro-priated by Queen Anne's Bounty to the benefice of Cheveley pursuant to the Tithe Act, 1936, shall be severed or diverted from that benefice and shall be appropriated by Queen Anne's Bounty for the augmentation of the benefice of Newmarket, All Sainte Saints.

Saints. "3. Diocese, archdeaconry and rural deanery: Upon the union taking effect, the benefice and parish of Newmarket, All Saints, shall belong to the diocese of Saint Edmundsbury and Ipswich and to the archdeaconry of Sudbury and to the rural deanery of Newmarket. "4. Patronage: The patronage of the benefices of Newmarket, All Saints, and Cheveley shall not be affected by anything recommended and proposed in this Scheme. "Schemme

### " SCHEDULE.

**Cheveley** in the County of Cambridge and in the diocese of Ely which is bounded upon the south-west by the parish of Wood Ditton in the county of Cambridge and in the diocese of Ely, upon the west by the said parish of Newmarket, All Saints, and upon the remaining sides, that is to say upon the north upon the east and upon the south-east by an imaginary line commencing at the point where the northern wall or fence of Sidehill Stud meets the boundary which divides the said parish of Newmarket, All Saints, from the said parish of Cheveley and extending thence eastward along the said wall or fence to the western end of the north side of the avenue or fence running parallel to the exercise track leading from Warren House and continuing eastward along the northern side of the said avenue or fence to its junction with the northern end of the wall or fence leading to Sandpit Plantation and extending thence south-wards in a straight line along the last mentioned wall or fence (passing Shepherd's House) to its junction with the north-eastern end of the wall or fence running through the last mentioned or fence running through the last mentioned plantation and forming the north-western boundary plantation and forming the north-western boundary of Sixteen Acre Plantation and extending thence south-westward along the last mentioned wall or fence to its junction with Duchess's Drive and extending south-westwards to a point in the middle of the said Drive upon the boundary which divides the said parish of Cheveley from the said parish of Wood Ditton."

And whereas the provisions of the Union of Benefices Measures 1923 to 1936, and the Union of Benefices Rules 1926 to 1930, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas an appeal against the said Scheme has been made to His Majesty in Council by the Parochial Church Council of the Parish of Cheveley and the Reverend Prebendary William Francis Buttle, Patron of the Benefice of Cheveley, and such appeal was referred to the Judicial Committee of the Privy Council on the 30th day of October, 1945:

And whereas the Lords of the said Committee, having taken the said appeal into consideration, re-ported to His Majesty in Council that the appeal ought to be dismissed and the said Scheme approved:

And whereas His Majesty was pleased, by and with the advice of His Privy Council, by Order of the 19th day of December, 1947, to approve the said Report:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order that it shall be and become effectual in law immediately upon the publication in this Order.
