

## COUNTY BOROUGH OF WEST HAM.

THE TOWN AND COUNTRY PLANNING (GENERAL DEVELOPMENT) ORDER, 1948.

*Direction made by the West Ham County Borough Council under Article 4.*

1. NOTICE is hereby given that the West Ham County Borough Council being the local planning authority for the County Borough of West Ham has made, and the Minister of Town and Country Planning has approved, a Direction under Article 4 of the above mentioned Order, the short effect of which is that the permission of the said Council as local planning authority must be obtained before development of the nature described in the Schedule below may be undertaken on certain land in the said County Borough.

2. A copy of the Direction and of the Map referred to therein may be seen during the usual office hours at the address set out below.

3. The said Direction is in force from the 29th April, 1949.

The rebuilding, restoration or replacement of buildings intended solely for residential purposes which have sustained war damage being development comprised within Class XI referred to in the First Schedule of the above mentioned Order and not being development of any other Class on those parts of the said land which at the 3rd day of September 1939 were known by the following descriptions:—

*Open Markets Byelaws.*

NOTICE is hereby given that the Mayor, Aldermen and Councillors of the Metropolitan Borough of Bermondsey (hereinafter referred to as "the Council") at their meeting on the 26th day of April 1949 made Byelaws relating to trading in the Council's open markets within the Borough, under Section 50 of the above Act.
