The Minister is not, in all cases, required to cause a local inquiry to be held. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made, as the objector may have no further opportunity to make such a statement.

### EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY.

#### *City of Plymouth.*

Notice is hereby given that the Minister of Town and Country Planning, in exercise of the powers conferred upon him by Section 23 of the Town and Country Planning Act, 1944, as amended by the Town and Country Planning Act, 1947, has prepared in draft and proposes to make an Order extinguishing the public rights of way over the following highways:—

Edinburgh Road (part from Fore Street to Willes Street);

Willes Street (whole).

### MINISTRY OF CIVIL AVIATION.

#### THE CIVIL AVIATION ACT, 1946 AND THE STATUTORY ORDERS (SPECIAL PROCEDURE) ACT, 1945.

#### NOTICE OF ORDER AS PROPOSED TO BE MADE BY THE MINISTER OF CIVIL AVIATION UNDER SECTION TWENTY-NINE OF THE CIVIL AVIATION ACT, 1946.

Notice is hereby given by the Minister of Civil Aviation pursuant to subsection (1) of section two of the Statutory Orders (Special Procedure) Act, 1945, and the First Schedule to that Act, that he proposes in exercise of the powers conferred upon him by section twenty-nine of the Civil Aviation Act, 1946, to make an Order declaring that the area of land hereunder specified shall be subject to control by directions given in accordance with the provisions of that section and giving general authority to him to give directions for any of the following purposes, that is to say:—

(a) for requiring the total or partial demolition of any building or structure within the said area;

(b) for restricting the height of trees upon any land within the said area, or for requiring any tree upon any such land to be cut down or reduced in height;

(c) for extinguishing any private right of way over land within the said area;

(d) for restricting the installation of cables, mains, pipes, wires or other apparatus upon, across, under or over any land within the said area;

(e) for extinguishing, at the expiration of such period as may be determined by the directions,

any subsisting right of installing or maintaining any such apparatus as aforesaid upon, across, under or over any land within the said area;

(f) for requiring that, before the expiration of such period as may be determined by the directions, any such apparatus shall be removed from any land within the said area;

and containing certain consequential, incidental and supplemental provisions.

Copies of the proposed Order, and of the map referred to therein, have been deposited at the offices of the Minister of Civil Aviation, 19-29, Woburn Place, London, W.C.1, and at the respective Council Offices of the Heston and Isleworth Borough Council, the Hayes and Harlington Urban District Council, the Yiewsley and West Drayton Urban District Council, the Staines Urban District Council, the Feltham Urban District Council, the Eton Rural District Council and the Egham Urban District Council, and may be inspected there free of charge at all reasonable hours.

Any objection to the proposed Order must be made in writing and addressed to the Minister of Civil Aviation, Strand, London, W.C.2 before the 15th day of July 1949 and should state the grounds of objection.

#### THE AREA OF LAND ABOVE REFERRED TO.

All the land delineated and coloured red on the map marked No. 1 annexed to the proposed Order, being land within a radius of approximately five miles from the point marked ⊕ within the circle verged red on the land delineated and coloured blue on the said map.
