PUBLIC LOCAL INQUIRY.

"Wilmar Lodge", Epsom Road, Ewell, Surrey.

The Minister of Town and Country Planning has nominated Sir Geoffrey Whiskard, K.C.B., K.C.M.G., to hold a public local inquiry for the purpose of hearing representations as to the effect on the public interest of the proposal of the War Department to use the premises known as "Wilmar Lodge", Epsom Road, Ewell, shown on the map of which copies have been deposited for public inspection at the offices of the Surrey County Council, County Hall, Kingston-upon-Thames, and the Epsom and Ewell Borough Council, Town Hall, Epsom. Sir Geoffrey Whiskard will accordingly attend at the Council Chamber, Town Hall, Epsom, at 10.30 a.m. on Tuesday, the 8th of November, 1949.

Any person desirous of making such representations is requested to notify the Minister of Town and Country Planning, 32, St. James's Square, London, S.W.1, as soon as possible, and in any case not later than the 1st November, of his wish to do so, and of the general nature of the representations he desires to make.
