The Import Duties (Drawback) (No. 16) Order, 1949, which extends the drawback allowed in respect of unrefined wood tar used in the manufacture of certain refined wood tar to include the

refined wood tar if mixed with resinous material or hydrocarbon oil or both.

This Order also reduces from 11 tons to 13 tons the quantity of unrefined material in respect of which drawback is allowable per ton of refined tar and increases the rate of drawback from 25s. to 41s. a
