- (b) If naturalised British subjects they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.
- (c) If not qualified under (a) or (b) of this paragraph they must satisfy the Civil Service Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service that an exception may properly be made in their favour. their favour.
- 4. Candidates must, on the date fixed as the last day for the receipt of applications, be registered Pharmacists and hold the certificate of the Pharmaceutical Society of Great Britain as Chemist and Druggist or as Pharmaceutical Chemist.
