LONDON PASSENGER TRANSPORT ACT, 1933.

RIVER BOARDS ACT, 1948.

Cumberland River Board Area.

NOTICE is hereby given that the Minister of Agriculture and Fisheries and the Minister of Health, in exercise of the powers conferred upon them by subsection 1 (a) of section 1 of the River Boards Act, 1948, intend to make an Order defining an area the drainage of which is directed towards rivers and their tributaries lying as to the greater part in the County of Cumberland and as to the remainder in the Counties of Westmorland and Northumberland together with adjoining areas as a river board area to be known as the Cumberland River Board Area.
