RIVER BOARDS ACT, 1948—SECTIONS 1 AND 2.

*Proposed Dee and Clwyd and North West Wales
River Board Areas.*

Whereas the Minister of Agriculture and Fisheries and the Minister of Health have given notice that they propose to make Orders under Section 1 (1) (a) of the River Boards Act, 1948, defining River Board Areas to be known as the Dee and Clwyd River Board Area and the North West Wales River Board Area; and whereas objections to the said proposal have been made, particularly with regard to the proposed inclusion of the Conway valley, Llandudno, Colwyn Bay and adjoining areas in the North West Wales River Board Areas, and the Ministers have decided that a public Local Inquiry should be held with respect to the said objections; notice is hereby given that the Ministers have appointed Sir Denys Stocks, C.B., O.B.E., to hold the said Inquiry and that he will attend for the purpose at the Council Chamber, Town Hall, Llandudno, on the 20th day of March, 1950 at 11 o'clock in the forenoon, and will then and there be prepared to receive representations from any persons interested in the matter of the said Inquiry.

EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY.

County Borough of West Ham.

Notice is hereby given that the Minister of Town and Country Planning, in exercise of the powers conferred upon him by Section 23 of the Town and Country Planning Act, 1944, as incorporated with the Town and Country Planning Act, 1947, has prepared in draft and proposes to make an Order extinguishing the public rights of way over parts of the highways known as Junction Street and Wellington Street, West Ham, E.16.

A copy of the draft Order and of a map showing the land over which the rights of way proposed to be extinguished subsist may be inspected at the West Ham Town Hall, Stratford, E.15, without payment of fee, between the hours of 9 a.m. and 4.30 p.m. (Mondays to Fridays), and 9 a.m. to 11.30 a.m. on Saturdays.

Any objection to this proposal must be made in writing and addressed to the Minister of Town and Country Planning, 32, St. James's Square, London, S.W.1, before the 5th day of June, 1950.

The Minister is not, in all cases, required to cause a local inquiry to be held. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made, as the objector may have no further opportunity to make such a statement.
