THE NORTH OF DUNSTON—STAFFORD TRUNK ROAD ORDER, 1950.

The Minister of Transport hereby gives notice that he has made an Order under subsection 2 of section 1 of the Trunk Roads Act, 1946, as amended by the Special Roads Act, 1949, whereby that part of the road from Wolverhampton to Stafford (Route A.449) in the County of Stafford, which extends from a point approximately 120 yards south of the milestone Stafford 3, Wolverhampton 13, in a general northerly direction to its junction with the Winchester—Preston Trunk Road at Stafford, will become a trunk road on the first day of April next after the date of the coming into operation of the Order.
