NOTICE is hereby given that the Urban District Council of Cannock, intend, after the expiry of one calendar month from the date of publication of this notice, to apply to the Minister of Food for confirmation of Byelaws made by the Council under Section 15 of the Food and Drugs Act, 1938, for securing the observance of sanitary and cleanly conditions and practices in connection with the handling, wrapping and delivery of food sold or intended for sale for human consumption and in connection with the sale or exposure for sale in the open air of food intended for human consumption.
