mortem and passed in accordance with criteria satisfactory to the Minister and (b) that all necessary precautions for prevention of danger to public health were taken in the preparing and packing of the meat product.

The Certificate being in the form of a stamp, recognition will apply only if the stamp is clearly impressed on the package containing the meat product and if the stamp has not in any other circumstances or on any other occasion been used as an Official Certificate.
