PUBLIC LOCAL INQUIRY.

Kidgem Copse.

The Minister of Town and Country Planning has nominated Mr. H. A. Hield, O.B.E., to hold a Public Local Inquiry for the purpose of hearing representations as to the effect on the public interest of the proposal of the War Department to use land shown on the map of which copies have been deposited for public inspection at the offices of the Berkshire County Council in Reading and the Wokingham Rural District Council in Wokingham. A Statement of the use to which the War Department propose to put the land, and a copy of Command Paper 7278 ("Needs of the Armed Forces for Training and Other Purposes," Part IX of which deals with the procedure for examining such proposals) have also been deposited for public inspection at the offices of the above mentioned local authorities. Mr. Hield will accordingly attend at the Village Hall, Barkham, at 10.30 a.m., on Wednesday, the 5th July, 1950.

Any person desirous of making such representations is requested to notify the Minister of Town and Country Planning, 32, St. James's Square, London, S.W.1, as soon as possible, and in any case not later than the 21st June of his wish to do so, and of the general nature of the representations he desires to make.
