The KING has been pleased by Warrant under His Sign Manual dated the 14th day of June, 1950, to appoint Richard Michael Arthur Chetwynd Talbot, Esquire, to be Deputy Chairman of the Court of Quarter Sessions of the County of Salop in accordance with the provisions of the Administration of Justice (Miscellaneous Provisions) Act, 1938.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 23rd June, 1950, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £240,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 26th June, 1950, to Saturday, the 1st July, 1950, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such

accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

COLONIAL STOCK ACTS, 1877 TO 1948.

ADDITION TO LIST OF STOCKS UNDER SECTION 2 OF THE COLONIAL STOCK ACT, 1900 (63 & 64 VIC. CAP. 62).

Pursuant to Section 2 of the Colonial Stock Act 1900 the Lords Commissioners of H.M. Treasury hereby give notice that the provisions of the Act have been complied with in respect of the undermentioned Stock inscribed in the United Kingdom:—Uganda Government 3½% Inscribed Stock, 1966-1969.

The restrictions mentioned in Section 2 Subsection (1) of the Trustee Act 1925 apply to the above Stock (see Colonial Stock Act 1900 Section 2).
