NOTICE OF SEIZURE UNDER THE
CUSTOMS ACTS.

Pursuant to Section 207 of the Customs Consolidation Act, 1876, I hereby give you notice that by virtue of the powers conferred on me by the Customs Acts and enactments amending and extending those Acts, I have seized as forfeited 103 (one hundred and three) rows of pearls found at 243, Commercial Road, London, E.1 on the 26th March, 1950, on the grounds that these pearls were unshipped from a ship in the United Kingdom (Customs Duties not being first paid or secured) and were prohibited goods imported in contravention of the Import of Goods (Control) Order, 1940, made by the Board of Trade under Section 1 of the Import Export and Customs Powers (Defence) Act, 1939, Whereby and by force of Section 3 of the said Import, Export and Customs Powers (Defence) Act and Section 177 of the said Customs Consolidation Act the said pearls are forfeited.

If you claim or intend to claim that the said pearls are not liable to forfeiture you should within one calendar month from the date of this Notice give notice of your claim or intended claim in accordance with the provisions of the said Section 207, and in default of such notice the pearls will be deemed to have been lawfully condemned and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be instituted for the forfeiture and condemnation thereof.

PUBLIC LOCAL INQUIRY.

Sennybridge and Fforest Fawr.

The Minister of Town and Country Planning has nominated Sir Wynn Wheldon, D.S.O., LL.D., to hold a Public Local Inquiry for the purpose of hearing representations as to the effect on the public interest of the proposal of the War Department to use land shown on the map of which copies have been deposited for public inspection at the offices of the Breconshire County Council in Brecon, the Monmouthshire County Council in Newport, the Ebbw Vale Urban District Council in Ebbw Vale, the Brecknock Rural District Council in Brecon, the Crickhowell Rural District Council in Crickhowell and the Abergavenny Rural District Council in Abergavenny. A Statement of the use to which the War Department propose to put the land, and a copy of Command Paper 7278 ("Needs of the Armed Forces for Training and Other Purposes," Part IX of which deals with the procedure for examining such proposals) have also been deposited for public inspection at the offices of the above-mentioned local authorities. Sir Wynn Wheldon will accordingly attend at the County Hall, Brecon, at 10.30 a.m. on Wednesday, the 26th July, 1950.

S.W.1, as soon as possible, and in any case not later than the 12th July, of his wish to do so, and of the general nature of the representations he desires to make.
