LAND DRAINAGE ACT, 1930.

River Great Ouse Catchment Board.

Yaxley Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries has now confirmed the Order made on the 18th May, 1950, in relation to the Scheme prepared by the River Great Ouse Catchment Board, under Section 4 (1) (b) of the Act, making provision for the following matters:—

(1) The constitution of the Yaxley Internal Drainage District and of the Drainage Board thereof.

(2) The abolition of the Yaxley First Drainage District and the Yaxley Second Drainage District and of the Commissioners thereof respectively.

(3) The making of alterations in certain Local Acts.

(4) Matters supplemental thereto or consequential thereon.

A copy of the Order may be seen at all reasonable hours at the office of the Clerk of the River Great Ouse Catchment Board, "Elmhurst", Brooklands Avenue, Cambridge, and also at the offices of the Ministry of Agriculture and Fisheries, Someries House, St. Andrew's Place, Regent's Park, London, N.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

NOTICE OF SEIZURE UNDER THE
CUSTOMS ACTS.

Pursuant to Section 207 of the Customs Consolidation Act, 1876, I hereby give you notice that by virtue of the powers conferred on me by the Customs Acts and enactments amending or extending those Acts I have seized as forfeited two packages, marked EF 83 and EF 84 respectively, containing three hundred and forty-three ocelot skins on the grounds that the said packages were entered as containing raw

Mexican ocelot skins whereas in fact the skins therein were not Mexican. Whereby and by force of Section 67 of the Customs Consolidation Act, 1876, the said packages and the goods therein are forfeited.

If you claim or intend to claim that the said packages and the goods therein are not liable to forfeiture you should within one calendar month from the date of this Notice give notice of your claim or intended claim in accordance with the provisions of the said Section 207 and in default of such notice the said packages and the goods therein will be deemed to have been lawfully condemned and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct.

If you give such notice within the time aforesaid legal proceedings will be instituted for the forfeiture and condemnation thereof.
