The Baking Wages Council (England and Wales) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for the revocation of the Baking Wages Council (England and Wales) Wages Regulation (Holidays) Order, 1947 (Order B.K.(30)) as amended by the Baking Wages Council (England and Wales) Wages Regulation (Holidays) (No. 2) Order, 1947 (Order B.K.(33)) and for the making of a Wages Regulation Order to give effect to proposals to vary the customary holiday provisions at present in operation.
