WHEREAS the Stockport Corporation (hereinafter referred to as "the Corporation") in whom are now vested the powers conferred by the Manchester Suburban Tramways Order, 1878, confirmed by the Tramways Orders Confirmation Act, 1878 (No. 2) (41 & 42 Vict. c. cxiii), and the Stockport and Hazel Grove Tramways Order, 1889, confirmed by the Tramways Orders Confirmation (No. 1) Act, 1889 (52 & 53 Vict. c. cx), have discontinued the working of the tramways described in the Schedule to this Order, being parts of the tramways authorised by the said Orders of 1878 and 1889, for the space of three calendar months (such discontinuance not being occasioned by circumstances beyond the control of the Corporation) and such discontinuance has been the Corporation) and such discontinuance has been proved to the satisfaction of the Minister of Transport (hereinafter referred to as "the Minister").
