Now, therefore, the Minister in exercise of his powers under section 41 of the Tramways Act, 1870 (33 & 34 Vict. c. 78), and of all other powers him enabling hereby makes the following Order:—

1. It is hereby declared that the powers of the Corporation in respect of the tramways described in the Schedule to this Order shall from the date of this Order be at an end.

2. The Interpretation Act, 1889 (52 & 53 Vict. 63), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. This Order shall come into operation on the twenty-eighth day of September, 1950, and may be cited as "The Stockport Corporation Tramways (Cesser of Powers) Order, 1950".
