ECRUITMENT UNDER NORMAL REGULATIONS OF DRIVING AND TRAFFIC EXAMINERS IN THE MINISTRY OF TRANSPORT. RECRUITMENT

1. Age.

1. Age. Candidates must have been born on or before 1st January, 1921. The Commissioners have not specified an upper age limit for this Competition.
