Order, 1950.

Weetwood Farm, Willington.

NOTICE is hereby given pursuant to Article 4 of the above Order that a direction has been made by the County Council and confirmed by the Minister of Town and Country Planning affecting development in 5 fields situate on the north side of Shay Lane in the Parish of Tarvin between Weetwood Lane and Mill Lane, and numbered 628, 630, 629, 634 and 644 in the Ordnance Survey (Cheshire Sheet XXXIX. 12, 1910 Edition).

The effect of the direction, which comes into force on the 3rd February, 1951, is that the following classes of development may not (except in case of emergency) be carried out on the said land without the express permission of the local planning authority, viz:—

(a) the erection or construction and the maintenance, improvement or other alteration of gates, fences, walls or other means of enclosure of whatever height;

(b) the use of land for any purpose (other than agriculture or forestry) for however short a period and the erection or placing of moveable structures on the land for the purposes of that use.
