

but who have been unable for good reason (e.g., service in the Forces; age) to acquire the necessary experience.

5. *Health and Character.* Every successful candidate must satisfy the Commissioners as to his or her health and character.

6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course, unless he or she has previously obtained permission to do so from the authority which administers the grant.

7. *Competition.* The Commissioners may summon to appear before a Selection Board all who are found to be prima facie eligible, or may, if they see fit, summon only those who are considered to be specially suitable for the posts for which they are being considered. The Board will take into consideration the candidates' record of education and experience if any, recommendations from persons named by the candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the interview; and on their estimation of all the above facts they will frame their recommendations. The decision of the Civil Service Commissioners shall be final.

8. *Candidates trained as Teachers.* Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g. the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

9. *Assignments.* Candidates will be required to state on their application forms whether they prefer drawing or surveying work. It will rest with the Ordnance Survey Authorities to determine to which duty successful candidates shall be allocated, but due regard will be paid, as far as possible, to candidates' preferences.

10. *Canvassing.* Any attempt on the part of candidates to enlist support for their application through Members of Parliament or other influential persons, except as referees to be named by them in their Applications Forms, will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, or other educational institution, in the Forces, or otherwise.

11. *Fee.* A successful candidate shall be required to pay a fee of 12s. 6d. before the issue of a certificate of qualification for appointment.

#### MINISTRY OF FOOD.

##### PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1937 AND 1948.

The Minister of Food gives notice in pursuance of the above named Regulations that he hereby recognises the Official Certificate of which particulars are given in the Schedule hereto as showing (a) that the meat from which the meat product to which the Certificate relates was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Minister and (b) that all necessary precautions for the prevention of danger to public health were taken in the preparing and packing of the meat product.

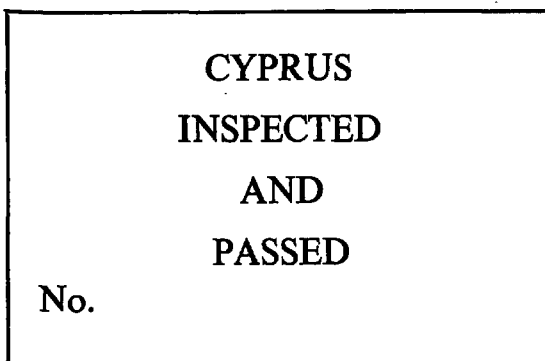
The Certificate being in the form of a label or stamp, recognition will apply only if the label is securely affixed to or the stamp is clearly impressed on the package containing the meat product.

The Certificate is of the same design as the one recognised on the 17th October, 1950, for the importation of carcase meat from Cyprus.

##### TOWN AND COUNTRY PLANNING ACT, 1947.

##### TRUNK ROADS ACT, 1946.

##### SPECIAL ROADS ACT, 1949.

The Minister of Transport hereby gives notice that he has made an Order under Section 14 of the Special Roads Act, 1949, the effect of which is to provide for the construction by the Minister of a new road near Monksmoor Bridge in the Rural District of Totnes to connect Ugborough Lane with the London—Penzance Trunk Road, and for stopping up that length of Ugborough Lane which will be superseded by the new road when that road is opened for through traffic.

Copies of the Order and of the plan referred to therein have been deposited at the Ministry of Transport, Berkeley Square House, London, W.1, and at the offices of the Devon County Council, The Castle, Exeter, and may be seen at all reasonable hours.
