SPECIAL ROADS ACT, 1949.

1. Church Street, from its junction with Market Street to its junction with Court Barton;
2. Court Barton, from its junction with Church Street to its junction with Gouldsbrook Terrace; and

3. Gouldsbrook Terrace, from its junction with Court Barton to its junction with West Street, all in the Urban District of Crewkerne, in the County of Somerset, will become trunk roads on the date on which the Order comes into operation.

LONDON TRAFFIC ACT, 1924.

LONDON PASSENGER TRANSPORT ACT, 1933.
