RECRUITMENT TO THE FOLLOWING GRADES IN THE HOME CIVIL SERVICE IN LONDON AND THE GREATER LONDON AREA: - CLERICAL ASSISTANT, MACHINE ASSISTANT, DUPLICATOR OPERATOR GRADE II.

1. Recruitment under these Regulations is restricted to women and girls.

Candidates must be at least 15 years of age on the date of application and under 20 years of age on 1st March, 1951.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must

either

(i) have at least one parent who is or was at death a British subject; or
(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment. appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight

years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing, or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character. (Note.—The fee for medical examination will be paid by the Commissioners.)

5. Examination.

The examination will consist of tests in common sense, accuracy, and arithmetic.

Candidates will be required to reach such a standard in these tests as to satisfy the Civil Service Commissioners.

- 6. Candidates upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.
