The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:

NORMAL RECRUITMENT FROM ESTABLISHED CIVIL SERVANTS FOR THE ADMINISTRATIVE CLASS OF THE HOME CIVIL SERVICE.

Candidates must be at least 21 and under 30 years of age on the 1st August, 1951.

Both men and women are eligible, but women will not ordinarily be appointed to posts in the Ministry of Defence, Admiralty, War Office, or Air Ministry.

3. Service.

Candidates must have had at least two years' service immediately prior to 1st August, 1951, in either

(a) an established situation in the Home Civil Service to which they were admitted with a certificate of the Civil Service Commissioners. For candidates who have been rejected or deferred on medical grounds for established appointment.

For candidates who have been rejected or deferred on medical grounds for established appointment, service on established conditions except for sick leave and pension may count towards the whole or part of this period; or

(b) a situation in the Office of the Receiver for the Metropolitan Police District, the Office of the Crown Agents for the Colonies, or Trinity House, after having been appointed to a post in one of those Offices as a result of a competition held by the Civil Service Commissioners.

4. Number of Attempts.

No candidate may compete in more than two Normal Limited Competitions for the Administrative Class.

5. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

6. Method of Selection.

(i) Written examination. All candidates will take a written examination, consisting of two papers in English (200 marks), a paper on Present Day (100 marks), a General Paper (100 marks), and a General Intelligence paper (100 marks): 500 marks in all.

(ii) Interview. A certain number, to be determined by the Civil Service Commissioners, of candidates who obtain the highest marks in the written examination will be summoned to tests of personal qualities at the Civil Service Selection Board

and to interview before the Final Selection Board.

The final order of merit will be decided by the Final Selection Board, which will take into account the candidate's record, his intelligence and personal qualities, his work in the written examination, and dualities, his work in the written examination, and the report on his performance in the series of tests of personal qualities. In the event of a tie between two or more candidates the Commissioners will decide which to declare successful. The Commissioners may at their discretion require a candidate to attend a second time before the Final Selection Board if they consider it necessary to enable them to reach a decision.

Assignment.

The Commissioners will decide to which Department each successful candidate is to be assigned; normally this will be to a Department other than that in which the candidate has been serving. A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment. Assignments will be made in accordance with the needs of the public service, but subject to this condition the wishes of candidates will where possible he taken wishes of candidates will, where possible, be taken into account.

8. Fee.
