WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 6th day of April, 1951, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, have prepared and now humbly lay before Your Majesty in Council the following Scheme with respect to some of the rural deaneries within the archdeaconries of Sarum and Wilts both in the diocese of Salisbury.

"Whereas it has been represented to us by the Right Reverend William Louis, Bishop of Salisbury, that the arrangements which are hereinafter recom-

whereas it has been represented to us by the Right Reverend William Louis, Bishop of Salisbury, that the arrangements which are hereinafter recommended and proposed with respect to some of the rural deaneries within the said two archdeaconries are desirable and we are of opinion that the same may be properly carried into effect:

"Now, therefore, with the consent of the said Bishop (in testimony whereof he has signed and sealed this Scheme), we, the said Church Commissioners, humbly recommend and propose that as from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order, first there shall be transferred from the rural deanery of Potterne lst Portion (or Potterne) (hereinafter called 'the said rural deanery of Potterne') in the said archdeaconry of Wilts to the rural deanery of Wylye 2nd Portion (or Heytesbury) (hereinafter called 'the said rural deanery of Heytesbury') in the said Archdeaconry of Sarum the parish the name of which is set forth in the First Part of the Schedule hereto; secondly there shall be transferred from the rural deanery of Wilton to the rural deanery of Wilton to the rural deanery of wilton to the rural deanery of the sural deanery of which is set forth in the First Part of the Schedule hereto; secondly there shall be transferred from the rural deanery of Wilton to the rural deanery of Wylye 1st Portion (or Wylye) (hereinafter called 'the said rural deanery of Wylye') the parish the name of which is set forth in the Second Part of the said Schedule; thirdly there shall be transferred from the rural deanery of Amesbury 1st Portion (or Alderbury) (hereinafter called 'the said rural deanery of Alderbury') to the said rural deanery of Wilton Alderbury) (hereinafter called 'the said rural deanery of Alderbury') to the said rural deanery of Wilton the parish the name of which is set forth in the Third Part of the said Schedule; fourthly there shall be transferred from the said rural deanery of Wilton, the rural deanery of Amesbury 2nd Portion (or Amesbury) (hereinafter called 'the said rural deanery of Amesbury) and the said rural deanery of Chalke to the said rural deanery of Alderbury the parishes the names of which are set forth in the Fourth Part of the said Schedule; fifthly there shall be transferred from the said rural deanery of Potterne to the rural deanery of Pottern 3rd Portion (or Bradford) (hereinafter called 'the said rural deanery of Bradford')

the parishes the names of which are set forth in the Fifth Part of the said Schedule; sixthly there shall be transferred from the rural deanery of Avebury 2nd Portion (or Cannings) (hereinafter called 'the said rural deanery of Cannings') to the rural deanery of Marlborough 1st Portion (or Marlborough) (hereinafter referred to as 'the said rural deanery of Marlborough') the parishes the names of which are set atter reterred to as 'the said rural deanery of Marl-borough') the parishes the names of which are set forth in the Sixth Part of the said Schedule; seventhly there shall be transferred from the said rural deanery of Cannings and the rural deanery of Potterne 2nd Portion (or Enford) (hereinafter called the said rural deanery of Enford') to the rural Potterne 2nd Portion (or Enford) (hereinafter called 'the said rural deanery of Enford') to the rural deanery of Marlborough 2nd Portion (or Pewsey) (hereinafter called 'the said rural deanery of Pewsey') the parishes the names of which are set forth in the Seventh Part of the said Schedule; eighthly the said rural deanery of Amesbury (as rearranged by this Scheme) in the said archdeaconry of Sarum and the said rural deanery of Enford in the said archdeaconry of Wilts shall (subject to the transfer of four parishes from the said rural deanery the said archdeaconry of Wilts shall (subject to the transfer of four parishes from the said rural deanery of Enford to the proposed new rural deanery of Devizes as hereinafter recommended and proposed) be united and shall together with the parish of North Newnton at present situate in the said rural deanery of Cannings, form one rural deanery within the said archdeaconry of Sarum and such new rural deanery shall be called 'the Rural Deanery of Avon' and shall comprise and consist of the parishes the names of which are set forth in the Eighth Part Avon and shall comprise and consist of the parishes the names of which are set forth in the Eighth Part of the said Schedule; ninthly the said rural deanery of Cannings (as rearranged by this Scheme) and the said rural deanery of Potterne (as so rearranged) shall be united and shall, together with the four parishes at present situate in the said rural deanery of Enford the names of which are mentioned in the Ninth Part of the said Schedule and with the parish of Seend at present situate in the said rural deanery Ninth Part of the said Schedule and with the parish of Seend at present situate in the said rural deanery of Bradford, form one rural deanery within the said archdeaconry of Wilts and such new rural deanery shall be called 'the Rural Deanery of Devizes' and shall comprise and consist of the parishes the names of which are set forth in the Ninth Part of the said Schedule and each of the parishes mentioned in the said Schedule shall be subject to the jurisdiction and authority of the rural dean of the rural deanery and of the archdeacon of the archdeaconry to which it is hereby transferred and shall not belong to or be a part of any other rural deanery or archdeaconry, nor be subject to the jurisdiction and authority of any other rural dean or of any other archdeacon.
