TRUNK ROADS ACT, 1946.

SPECIAL ROADS ACT, 1949.

The Minister of Transport hereby gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, the effect of which will be:—

(a) to provide for the re-aligning of the carriage-way of that length of Desford Lane at Narborough in the Rural District of Blaby in the County of Leicester which extends south-eastwards for a distance of approximately 50 yards from its junction with the Bath—Cheltenham—Evesham—Coventry—Leicester—Lincoln Trunk Road;

(b) to provide for the re-aligning of the carriage-way of that length of the road leading to Enderby at Narborough aforesaid which extends north-westwards for a distance of approximately 55 yards from its junction with the said trunk road;

(c) to provide for the widening of the road leading to Enderby on its northern side at its junction with the said Trunk Road by an area of approximately 391 square yards.

Copies of the draft Order and the plan showing the proposed improvements may be inspected by any person free of charge at all reasonable hours
