During the recent riots in Singapore, the bus in which Trooper Moppett was riding was stopped by a crowd in order to set it on fire. Trooper Moppett escaped by a rear window and got away. Shortly afterwards while skirting another crowd he saw a car being attacked by some 20 to 30 hooligans. He went straight into them brushing them aside and found a European woman and two children being attacked. One child was injured. Having escorted them to the Mountbatten Club and having given them "first aid" he returned and rescued the car. Through-out Trooper Moppett acted with great coolness and courage and upheld the highest traditions of the Army.

The Lords Commissioners of His Majesty's Treasury hereby give notice that They have made an Order under Section 9 of the Finance Act, 1932, Section 7 (2) of the Finance Act, 1934, Section 1 of the Import Duties (Emergency Provisions) Act, 1939, and Section 12 of the Finance Act, 1950, viz.:—

The Import Duties (Drawback) (No. 18) Order, 1951, which approves a new scheme for the allow-ance of drawback of Customs duty paid on certain kinds of imported paper used in the manufacture of unused open-topped bags without flaps.

Under this scheme, drawback is payable at vary-ing rates, according to the amount of the duty paid per ton of the imported paper, instead of, as hitherto, at flat rates according to the variety of paper.
