**BOROUGH OF LYMINGTON.**

COAST PROTECTION ACT, 1949.

The Lymington Borough Council acting in their capacity as coast protection authority, hereby give notice under subsection (1) of section 5 of the above Act that they propose to carry out coast protection work as described herein at Milford-on-Sea in the said Borough.

The work will consist of extending the existing stepped wall for a length of 300 yards eastward and constructing a breastwork for a further 550 yards eastward. Twenty-eight groynes of varying lengths are to be built at intervals along these defences. It is also proposed to construct a 150 feet length of revetment at the junction of the new stepped wall and the revetment and 100 feet of revetment at the east end of the breastwork.

The estimated cost of the work is £89,642.

Any person, may not later than the 23rd day of August, 1951, serve a written notice of objection to the above proposal on the Minister of Local Government and Planning and on the above-mentioned authority. Any such notice must contain a statement of the grounds of objection and must be sent by pre-paid post to the Secretary, Ministry of Local Government and Planning, Whitehall, London, S.W.1, and to the clerk of the authority at the address shown below.
