RECRUITMENT UNDER NORMAL REGULATIONS TO THE SITUATION OF OFFICER OF CUSTOMS AND EXCISE (MALE)

1. No candidate may compete more than twice in all under Normal Regulations and under Reconstruc-tion Regulations for the situation of Officer of Customs and Excise.

2. Age
