The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:--

RECRUITMENT TO THE SITUATIONS OF DEPUTY KEEPER, AND ASSISTANT KEEPER, (GRADE I, OR GRADE II), AT THE TATE GALLERY.

1. Age (i) Candidates for the posts of Deputy Keeper and Assistant Keeper, Grade I must be at least 30 years of age on 1st August, 1951. The Commissioners have not specified an upper age limit for these posts; in general, however, Government Depart-ments require a reasonable period of service from persons newly appointed to the Civil Service, and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates who are over 50 years of age. (ii) Candidates for the post of Assistant Keeper,

(ii) Candidates for the post of Assistant Keeper, Grade II must be at least 22 and under 26 years of age on 1st August, 1951, provided that exception-ally well qualified candidates may be admitted up to the age of 30. But

(a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age.

(b) a candidate who has served in H.M. Forces otherwise than on a regular or short-service en-gagement may deduct the period of such service from his actual age, up to a maximum of two years;

(c) candidates who have served in any estab-lished post to which they were admitted with the Certificate of the Civil Service Commissioners, or who have served on established conditions except for sick leave and pension in a post to which such a Certificate would normally apply, may deduct from their actual age any time not exceeding two years which they may have spent in such service. in such service

2. Sex and Marriage

(i) Both men and women may compete under these Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity naid marriage gratuity paid.

3. Nationality

Candidates must be British subjects. The also satisfy one of the following conditions: They must

(a) If natural-born British subjects, they must either

(i) have at least one parent who is, or was at death, a British subject; or
(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their empointment appointment.

appointment. (b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment. (c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbring-ing or residence, or by reason of national service, that an exception may properly be made in their favour. favour.

4. Qualification Candidates must normally have a University degree with first or second class Honours, though candidates without this qualification may be con-sidered if they are otherwise exceptionally well qualified by training or experience. In addition

(a) For the Deputy Keeper post, candidates must have a wide knowledge of the history, theory, and practice of the visual arts. It is desirable that they should have experience of administration and staff control, and of research and staff control, and of research and and

the preparation of written material; a know-

the preparation of written material; a know-ledge of publishing and processes of reproduction and printing, and a knowledge of one or more continental languages will be an advantage. (b) For the Assistant Keeper post, (Grade I or II) candidates must have some knowledge of the history, theory and practice of the visual arts and should preferably have a knowledge of one or more continental languages.

5. Health and Character

The successful candidates must satisfy the Com-missioners as to health and character.

Competition

6. Competition Candidates who appear from their applications to have the best qualifications and experience will be summoned for interview in London before a Selection Board which will recommend to the Civil Service Commissioners the candidates considered best fitted for appointment. The Commissioners' decision will be final.

7. Candidates trained as Teachers

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Iraland has been particled Education for Northern Ireland) has been notified to the Commissioners.

8. Canvassing

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their Application Forms, will disqualify them for appointment.

9. Fee The successful candidates will be required to pay a fee of £1 10s. before the issue of a certificate of qualification for appointment.

Treasury, the following amendment has been made in the Normal Regulations for recruitment to basic grades of Professional Engineers, General Service Class and linked Departmental Variants dated 20th June 1951 and multipled in the London Gazette 29th June, 1951, and published in the London Gazette of the same date viz.:

Candidates must:— (i) be Corporate Members of the Institution of Electrical Engineers, or be Associate Fellows of the Royal Aeronautical Society; or (ii) have passed Sections A and B of the Associate Membership Examination of the Institu-tion of Electrical Engineers, or hold an educational qualification recognised by that Institution as giving exemption from examination in those Sections; but candidates admitted under this sub-section must normally obtain the qualification in sub-section (i) above before they are confirmed in their appointabove before they are confirmed in their appoint-ment (Exception may be made in special circum-stances provided for in Regulation 4A (i) (b) cn

page 4); or (iii) hold a first or second-class Honours degree in Physics or Engineering

provided that the Commissioners may at their dis-cretion admit, exceptionally, candidates who furnish evidence of high professional attainment. In addition all candidates must produce evidence that both the examination subjects included in their qualifications and their practical experience justify their employment on civil aviation telecommunica-tions duties.
