**TOWN AND COUNTRY PLANNING  
ACTS, 1944 AND 1947.****EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY.**

*County Borough of West Ham.*

NOTICE is hereby given that the Minister of Local Government and Planning in exercise of the powers conferred upon him by Section 23 of the Town and Country Planning Act, 1944, as incorporated with the Town and Country Planning Act, 1947, proposes to make an Order extinguishing the public rights of way over parts of Montague Street and Marcus Street, West Ham.

A copy of the draft Order and a map showing the lands over which the rights of way proposed to be extinguished subsist may be inspected at the Town Clerk's Department, West Ham Town Hall, between the hours of 9 a.m. and 4.30 p.m., Mondays to Fridays, and 9 a.m. and 11.30 a.m. on Saturdays.

Any objection to this proposal must be made in writing, and addressed to the Minister of Local Government and Planning, Whitehall, London, S.W.1, before the 14th day of December, 1951.

The Minister is not, in all cases, required to cause a local inquiry to be held. It is important, therefore, that an objection should include a full statement in writing of the grounds on which objection is made, as the objector may have no further opportunity to make such a statement.
