battle, nor under the stimulus of excitement but in cold blood.

Realizing that only by endangering his own life could the Sergeant's life be saved Captain Durie seized the Sergeant and succeeded in pulling him away from the vehicle. They both fell to the ground. The Sergeant had ceased breathing, and was unconscious. His hands and feet were seriously injured by severe electric burns.

Captain Durie had himself received a heavy electric

shock and was burned. In spite of his own injuries, however, he immediately arranged for the Sergeant to be given artificial respiration whilst he himself telephoned for a doctor and an ambulance.

The Sergeant's life was saved.

That the Signal Sergeant did not lose his life was due entirely to the prompt and very gallant action taken by Captain Durie. There can be little higher praise than that it can be said of a person that he was prepared to risk his own life to save his comrade's. This tribute can be very worthily paid to Captain Durie.
