#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 28th day of September, 1951, in the words and figures following, that is to

"We, the Church Commissioners, acting in pur-suance of the New Parishes Measure, 1943, have pre-pared and humbly lay before Your Majesty in Council the following Scheme for constituting a new Parish to be taken out of the parishes of Saint Faith, Win-chester, and Christ Church, Winchester, in the diocese of Winchester.

### " SCHEME

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish: "And whereas we are satisfied that a suitable en-

dowment therefor will be provided:

dowment therefor will be provided: "And whereas we have not approved any conse-crated church within the area as suitable to be the parish church of the new parish: "Now, therefore, with the consent of the Right Reverend Mervyn, Bishop of Winchester (in testi-mony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:--

"1. Constitution. (a) As from the day of the date of the licence thereto of a Minister, the area defined in the sub-joined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual

annexed shall be (b) purposes. "(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

become a new parish. "(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Luke, Stanmore'.

"2. Archdeaconry and Rural Deanery: "The parish shall be in the Archdeaconry of Win-chester and in the rural deanery of Winchester.

## "THE SCHEDULE.

"The area comprising:

i.e area comprising: — (a) All that part of the parish of Saint Faith, Winchester (coloured pink on the map annexed hereto) which is bounded upon the southwest by the parish of Compton, upon the west by the parish of Hursley, upon the north by the parish of Christ Church, Winchester, and upon

the remaining sides, that is to say, upon the east and south-east, by an imaginary line com-mencing at a point on the boundary which divides the parish of Christ Church, Winches-ter, from the parish of Saint Faith, Winchester, in the middle of the main line of the British Pailway (Southern Besider and cald raid Railways (Southern Region) where the said rail-way line crosses Stanmore Lane, and continu-ing thence southwards along the middle of the said railway line to a point in the middle of Whiteshute Lane where the said railway line crosses Whiteshute Lane and continuing thence continue turner to along the middle of Whiteshute southwestwards along the middle of Whiteshute Lane to a point opposite to the southern end of the wall or fence which divides close numbered 49 on the map annexed hereto from close numbered 58e, and continuing thence northwards to and along the last-mentioned wall or fence to a point in the middle of the track or footpath which runs southwestwards across close numbered 49 and then along the northwestern

path which runs southwestwards across close numbered 49 and then along the northwestern side of close numbered 58e, and continuing thence southwestwards along the middle of the said track or footpath to the boundary which divides the parish of Saint Faith, Winchester, from the parish of Compton. ) All that adjacent part of the parish of Christ Church, Winchester (coloured green on the map annexed hereto), which is bounded upon the northwest by the parish of Weeke, upon the southwest and southeast by the parish of Saint Faith, Winchester, and upon the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of Saint Faith, Winchester, from the parish of Saint Faith, Winchester, from the parish of Saint Faith, Winchester, from the parish of Saint Faith, Winchester, in the middle of the main line of the British Railways (Southern Region) where the said railway line crosses Airlie Road and continuing thence northwestwards along the middle of Airlie Road for 7½ chains to a point opposite the northeastern end of the wall or fence which divides close numbered 297 from close numbered 296 on the map annexed hereto and continuing thence southwestwards to and along the last-mentioned wall or fence " (b) hereto and continuing thence southwestwards to and along the last-mentioned wall or fence and along the wall or fence which divides close numbered 160 from close numbered 165 and continuing thence westwards along the walls or continuing thence westwards along the walls or fences which divide closes numbered 164, 162, 161, 317, 318, 319, 232, and 250 from closes numbered 160 and 231 and continuing thence southwestwards along the walls or fences which divide close numbered 231 from closes num-bered 250, 226a and 226b and in the same straight line to a point in the middle of Battery Hill opposite to the southwestern end of the last-mentioned walls or fences and continuing thence westwards along the middle of Battery Hill and in the same straight line to the boun-dary which divides the parish of Christ Church, Winchester, from the parish of Weeke."
