writing dated the 21st September, 1950, and made pursuant to Section 9 of the New Parishes Measure,

1943:
"Now, therefore, with the consent of the Right Honourable and Right Reverend William, Lord Bishop of London, (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is

"1. Constitution:

"(a) As from the date of the licence thereto of a Minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes until the approval by us, the said Church Commissioners, of the consecrated church known as Chelsea Old Church.

"(b) As from the date of the approval by us, the said Church Commissioners, of the said consecrated church the area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of All Saints (Chelsea Old Church), Chelsea'.

"2. Archdeaconry and Rural Deanery:
"The said district and parish shall be in the Archdeaconry of Middlesex and in the rural deanery of Chelsea.

"THE SCHEDULE

"The area (coloured pink on the map) com-

prising:—

"All those contiguous portions of the parishes of St. Luke, Chelsea; St. Andrew, Chelsea; and Christ Church, Chelsea, which taken together are bounded upon the southwest by the parish of St. John, Chelsea, upon the southeast by the River Thames and upon the remaining sides by an imaginary line commencing at a point in the middle of the River Thames opposite to the middle of the southeastern end of Cheyne Gardens on the boundary of the parish of Christ Church, Chelsea and extending thence northwestwards to and along the middle of Cheyne Gardens and Manor Street to a point opposite to the middle of Manor Gardens and continuing thence southwestwards to and along Manor Gardens to a point opposite to and the end of the southwestern wall of the Town Hall of the Metropolitan Borough of Chelsea and continuing thence northwestern prising: western wall of the Town Hall of the Metropolitan Borough of Chelsea and continuing thence northwestwards to and along the said wall and then in the same direction to the middle of King's Road and continuing thence southwestwards along the middle of King's Road to a point opposite to the northwestern end of the wall or fence which divides the house and premises known as No. 245 King's Road from the house and premises known as No. 247 King's Road and continuing thence southeastwards first to and then along the last mentioned wall or fence and then along the wall or fence at the rear of the houses and premises on the southwestern side of Bramerton Street to the northeastern end of the northwestern wall or fence of the house and rear of the houses and premises on the southwestern side of Bramerton Street to the northeastern end of the northwestern wall or fence of the house and premises known as No. 35 Glebe Place and continuing thence southwestwards along the last mentioned wall or fence of the last mentioned house and premises and then northeastwards along the southeastern wall or fence of the said house and premises to a point opposite to the middle of Glebe Place and continuing thence southeastwards in a straight line along the middle of Glebe Place to a point opposite to the northeastern end of the northwestern wall of the L.C.C. School and continuing thence southwestwards to and along the last mentioned wall and then in a straight line in the same direction to the southeastern wall of St. Luke's Institute and continuing thence southwestwards and then northwestwards along the side of the said Institute to the wall or fence constituting the southeastern boundary of the parsonage house of St. Luke, Chelsea, and continuing thence southwestwards along the last mentioned wall or fence to a point opposite to its southwestern end in the middle of Old Church Street (formerly known as Church Street) and continuing thence northwestwards along the middle of Old Church Street to the middle of King's Road and continuing thence southwestwards along the middle of Old Church Street to the middle of King's Road and continuing thence southwestwards along the middle of St. Andrew, Chelsea, from the parish of St. John, Chelsea."

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.
