WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 9th day of November, 1951, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Christ Church, Eccleston, in the diocese of Liverpool.

### "SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefore will be provided:

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Clifford, Bishop of Liverpool (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme) we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

"1. Constitution:

"(a) As from the day of the date of the licence thereto of a Minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Matthew, Thatto Heath, Saint Helens'.

## "2. Archdeaconry and Rural Deanery:

"The parish shall be in the Archdeaconry of Warrington and in the rural deanery of Prescot.
