"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Tom, Bishop of Hereford (in witness whereof he has signed the Scheme), for effecting the disunion of the united benefice of Canon Frome with Munsley in the diocese of Hereford.

## " SCHEME.

"Whereas the benefice of Canon Frome and the benefice of Munsley were permanently united to-gether to form one benefice with cure of souls in pursuance of an Order of Her late Majesty Queen Victoria in Council dated the 11th day of December,

Victoria in Council dated the 11th day of December, 1854:

"And whereas the Bishop of the said diocese of Hereford has forwarded to us, the said Church Commissioners, provisional proposals pursuant to the said Pastoral Reorganisation Measure, 1949, recommending that the union of the benefices of Canon Frome and Munsley should be dissolved, that the said benefice of Canon Frome should be held in plurality with the benefice of Stretton Grandison with Ashperton and that the said benefice of Munsley should be held in plurality with the benefice of Alyton with Pixley, all of which benefices are situate in the said diocese of Hereford:

"And whereas effect can be given to the said."

"And whereas effect can be given to the said proposals so far as they relate to the dissolution of proposals so far as they relate to the dissolution of the said union by Scheme prepared by us and confirmed by Order of Your Majesty in Council pursuant to the said Union of Benefices Measures and in so far as they relate to the said pluralities by subsequent Orders made by the said Bishop pursuant to the said Pastoral Reorganisation Measure:

"Now, therefore, we, the said Church Commissioners, do humbly recommend and propose to Your Majesty as follows, that is to say:—

The endowments and property of the said united benefice shall be divided and distributed as follows, that is to say (1) out of the endowments now held by us, the said Church Commissioners, on behalf of the said united benefice a capital sum sufficient to produce an annual income of £200 and (2) the proceeds (together with any accumulated interest thereon) of the sale of the parsonage house belonging to the united benefice are now held by us shall be assigned and annexed to the benefice of Canon Frome and all other the endowments and
