of Hook Road and continuing thence southwards along the middle of Hook Road for a distance of three-quarters of a mile or thereabouts to a point south of Horton Farm and opposite to the middle of the western end of the bridle path which runs northeastwards from Hook Road to the Horton Light Railway Line, and continuing thence northeastwards to and along the middle of the said bridle path to the boundary which divides the parish of Christ Church, Epsom Common, from the parish of Ewell, and continuing thence southeastwards along the said boundary and then westwards along the boundary which divides the parish of Saint Barnabas, Epsom, and then westwards along the boundary which divides the parish of Saint Barnabas, Epsom, from the parish of Christ Church, Epsom Common, to a point opposite to the middle of the southern end of Long Grove Road and continuing thence northwestwards along the middle of Long Grove Road to a point opposite to its northwestern end in the middle or Horton Lane and continuing thence first to and then along the middle of the track or footpath which runs along the outside of the southern boundary of the Long Grove Mental Hospital to its junction with the track or footpath which runs northwards from Horton Lane and continuing thence northwards along the middle of the last-mentioned track or footpath to the boundary which divides the parish of to the boundary which divides the parish of Christ Church, Epsom Common, from the parish of Chessington.

"(c) The territory to be annexed to the parish of Ewell:

All that part of the parish of Christ Church, Epsom Common, which is adjacent to the parish of Ewell and includes the Ewell Mental Hospital and grounds and which would otherwise be detached from the parish of Christ Church, Epsom Common, after the alteration of boundaries proposed in paragraph (b) (iv) of this Schedule."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied

with:
And whereas the said Scheme has been approved by His Majesty in Council:
Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.
And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Guildford.

Discontinuance

'THE BURIAL GROUNDS (LILLESHALL) ORDER, 1951. 4th December, 1951

At the Court at Buckingham Palace, the 4th day of December, 1951.

PRESENT

The KING's Most Excellent Majesty in Council.

WHEREAS the Minister of Local Government and WHEREAS the Minister of Local Government and Planning, after giving 10 days' previous notice of his intention in that behalf, did under the provisions of the Burial Act, 1853, 16 & 17 Vict. c. 134, as amended by subsequent enactments, make a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Lilleshall in the County of Salon save with the previous approval of

burial ground in the Civil Parish of Lilleshall in the County of Salop, save with the previous approval of the Minister of Local Government and Planning, should be prohibited, and that burials should be discontinued therein as hereinafter directed:

And whereas by an Order in Council of the 4th October, 1951, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 26th day of November next, and such Order has been published in the London

Gazette, and copies thereof have been affixed, as required by the said Act:
And whereas by an Order in Council of the 1st November, 1951, S.I. 1951 No. 1900, the style and title of the Minister of Local Government and Planning was changed to "The Minister of Housing and Local Government."

Now therefore His Majesty is pleased by and

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. No new burial ground shall be opened in the said Parish of Lilleshall save with the previous approval of the Minister of Housing and Local Government, and burials shall be discontinued therein as follows, viz.:—

Lilleshall.—Forthwith and entirely in the Churchyard of the Parish Church of Lilleshall in the said Parish.

Provided that-

(a) In any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brick-

work properly cemented.

(b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

(c) In the said Churchyard, in any grave space in which no interment has heretofore taken

in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (Lilleshall) Order, 1951.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 14th day of January day of January.
